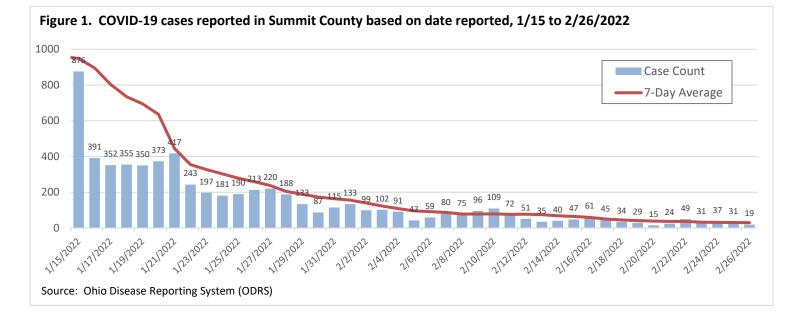
**COVID-19 Case Data:** Public health data can be presented in different ways. For COVID-19 case reporting, **Summit County Public Health (SCPH)** reports case count data by the date each case is reported. This provides SCPH and community partners a real-time picture of case reporting and public health response, such as case interviews, contract tracing, outbreak investigations and mitigation efforts. Summit County reports confirmed and probable cases that are active cases at time of reporting, and does not include cases reported due to positive antibody test results.

The **Ohio Department of Health (ODH)** reports data the date that symptoms were first experienced (onset date) for all confirmed and probable cases. The case graph by onset date (also known as an epidemiological curve) provides valuable information on the dynamics of disease transmission and outbreaks. However, the data in the most recent two weeks of the onset date curve will be incomplete, as many of the cases first experiencing symptoms on those dates have not yet been diagnosed and/or reported to the health department.

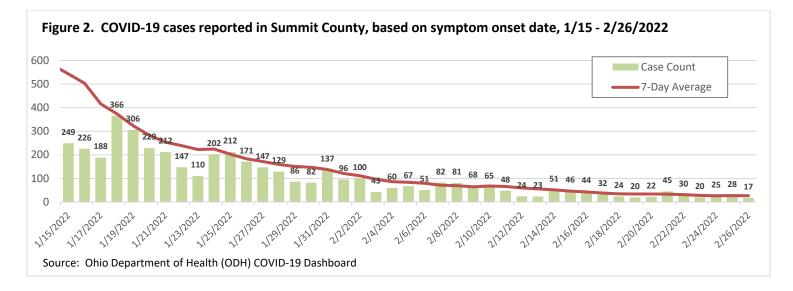
In this report, graphs for case counts, hospitalizations and deaths include data for the past five weeks. Graphs with data for the entire pandemic are included at the end of the report. In the graphs with daily data, 7 day averages are calculated to correct for data variability

# **Summit County Surveillance Data:**

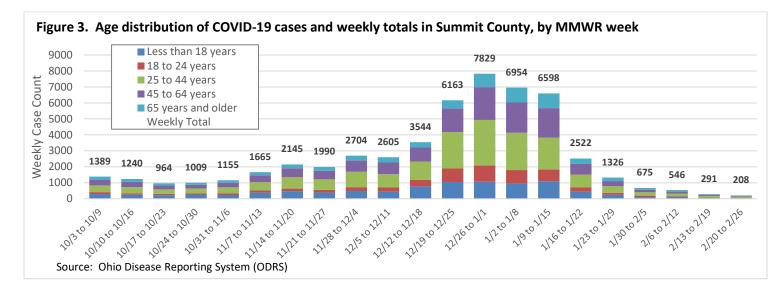
**COVID-19 Case Data:** Data based on the reporting date (Figure 1) indicates that the 7-day average daily count reached a maximum of 1,231 cases per day on January 3, then decreased to 29 cases per day by February 26. There were reporting anomalies on January 14 and 15, when a reporting backlog was resolved in the state system (ODRS).

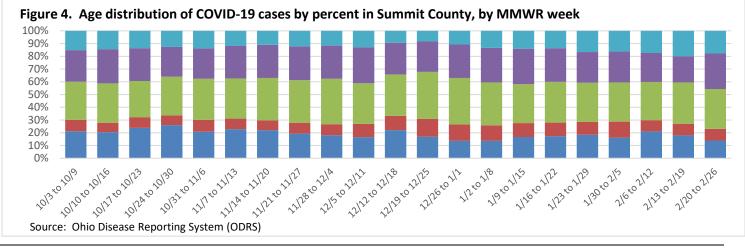


Based on symptom onset date (Figure 2), the 7 day average daily count reached a maximum of 1,292 cases per day on January 1. Since then, the 7-day average decreased to 27 cases per day on February 26. Although data with a case onset after February 5 are considered to be incomplete, COVID-19 activity has been decreasing.



Weekly cases by age distribution: Figure 3 and 4 display the weekly age distribution of new cases reported since October 3, 2021, based on date reported. Since March 2020, children below the age of 18 accounted for 14.0% of cases, young adults aged 18 to 24 accounted for 12.0% of cases, and older adults aged 65 years or older accounted for 14.2% of cases. During Week 8 (2/20 – 2/26/2022), children accounted for 13.9% of the cases reported and young adults accounted for 9.1% of cases.

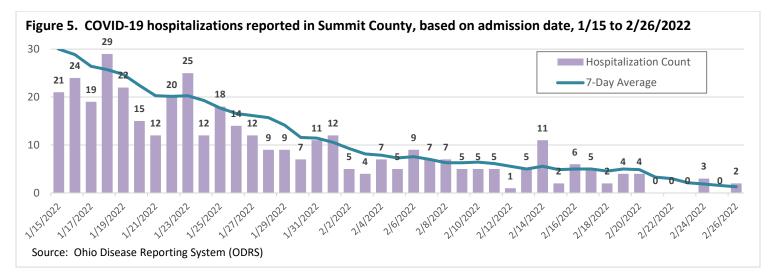

#### Summit County Hospitalization and Death data:

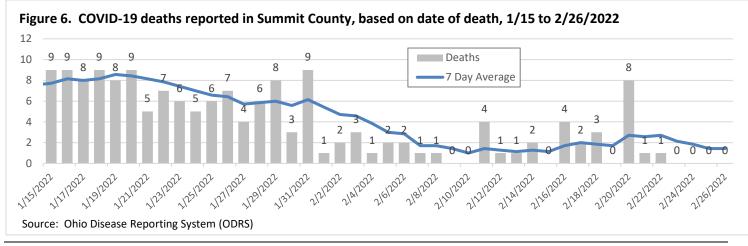
Due to the progression of the COVID-19 illness and reporting delays, *hospitalization data in the previous two to four weeks may be incomplete*. On January 1, 2022, the 7 day average for hospitalizations was 39.4 admissions per day, increased to 44.1 admissions per day by January 5, then decreased to 1.3 admissions per day by February 26.



Although the Ohio Department Health changed its COVID-19 death reporting to include confirmed cases only, Summit County Public Health will continue to include probable cases in its death statistics. Case counts and hospitalization counts also include confirmed and probable cases. Table1 lists the number of COVID-19 deaths by month since the beginning of the pandemic. The highest number of COVID-19 deaths occurred in December, 2020 with 315 deaths reported due to COVID-19, followed by 188 deaths in January, 2021. Through 2021, COVID-19 deaths per month decreased steadily to low of 11 deaths in July. However, COVID-19 deaths are again on the increase with 62 deaths reported in September, 74 deaths in October, 94 deaths in November, 196 deaths in December, and 216 deaths in January, 2022. 40 deaths were reported through February 26. COVID-19 deaths can occur up to several weeks or months following the initial diagnosis and test result.

# **MIS-C Cases in Summit County**

According to the CDC, **Multisystem inflammatory syndrome in children (MIS-C)** is a condition where different body parts can become inflamed, including the heart, lungs, kidneys, brain, skin, eyes, or gastrointestinal organs. Children with MIS-C may have a fever and various symptoms, including abdominal (gut) pain, vomiting, diarrhea, neck pain, rash, bloodshot eyes, or fatigue. Although we cannot yet definitively say what causes MIS-C, many children with MIS-C tested positive for the SARS-CoV-2 virus, had COVID-19 symptoms, and/or had been around someone with COVID-19.

**Summit County:** As of February 26, 2022, 27 cases of MIS-C have been reported in Summit County (22 confirmed and 5 suspected status). The age range of these cases is 2 to 18 years old, with an average age of 9.0 years. All of these cases were hospitalized, with an average stay of 5.5 days. The length of hospitalization ranged from 3 to 13 days.

# New cases per capita (past 14 days)

The 14-day population case rates based on symptom onset decreased to 78.9 cases per 100,000 during the latest reporting period of February 13 to 26, 2022. The two previous reporting period rates were 184.5 and 121.3 cases per 100,000.

# **CDC COVID-19 Community Level Indicators**

CDC currently updates the community level on a weekly basis, and this weekly report will report the most recent community level and the relevant indicators.

## Total new cases in past 7 days, per 100,000 residents

Presenting the 7 day new case total as a rate allows for counties with different population sizes to be appropriately compared.

# During the latest reporting period (2/24 to 3/2/2022), the 7-day new case rate in Summit County decreased to 34.2 cases per 100,000 residents.

# New COVID-19 admissions per 100,000 population (7-day total)

The new COVID-19 hospital admissions rate during the latest reporting period (2/23 to 3/1/2022) was at 4.6 admissions per 100,000 residents.

## Percent of inpatient beds occupied by COVID-19 patients (7-day average)

The percent of inpatient beds occupied by COVID-19 patients during the latest reporting period (2/23 to 3/1/2022) was at 4.0%

# **COVID-19 Community Level**

The COVID-19 community level is determined by the higher of the new admissions and inpatient beds metrics, based on the current level of new cases per 100,000 population in the past 7 days

During the latest reporting period (2/24 to 3/2/2022), the COVID-19 community level is: Low / Green.

# **Summit County vaccination rates**

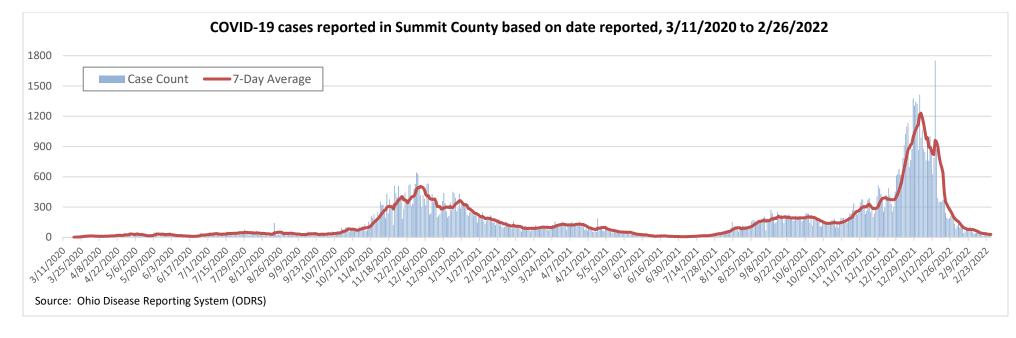
CDC vaccination data represents all vaccine partners including jurisdictional partner clinics, retail pharmacies, long-term care facilities, dialysis centers, Federal Emergency Management Agency and Health Resources and Services Administration partner sites, and federal entity facilities.

### As of February 28, 2022, the fully vaccinated rates in Summit County were:

Total population: 62.6%, percent of fully vaccinated residents who received the booster dose: 52.9% Ages 5 – 11 years: 28.4%, Ages 12 – 17 years: 53.9% Ages 12 and over: 69.8%, Ages 18 and over: 71.3%, Ages 65 and over: 88.4%.
